Policies and Information

In order to ensure a fun, safe and healthy environment for all daycare participants, Happy Puppy asks that our guests adhere to the following policies. Thanks!

- All daycare/boarding dogs must be at least 12 weeks of age or older.
- All dogs 6 months of age or older must be spayed or neutered.
- All dogs must be up to date with our required vaccinations at all times [distemper/parvo (all ages), bordetella (all ages and in system for at least 3 days whenever not current), and rabies (5 months and older)] and must have a negative fecal exam within the last year prior to each visit (must also be the most recent fecal exam results). Puppies need to have all the required boosters in addition to each initial vaccine shot (one additional bordetella and 2 additional distemper/parvo). Owners must submit a form from their veterinarian verifying this and must provide a new form each time these services are updated. Reminder date forms from your veterinarian tend to work best. - All dogs must be in good health and have not been ill with a communicable condition in the last 30 days prior to any visit.
- All dogs must be current with flea-tick and heartworm prevention prior to each visit.
- We reserve the right to refuse a visit if your dog arrives sick, flea-infested, or if there are any other issues that are unsafe. If there are any issues with your dog after drop-off that we feel are unsafe, he/she will be quarantined and you will be asked and expected to pick him/her up immediately. Initials _____
- All dogs must be non-aggressive without severe kennel/crate anxiety and we prefer they are not food, water, or toy protective. We reserve the right to deny daycare services if your dog shows aggressive or excessive behavior, which disrupts the daycare experience of the other dogs.
- All dogs must complete the registration process, including a temperament evaluation by Happy Puppy, and have all necessary forms up to date. There is a \$30.00 non-refundable registration/temperament test fee and is due at the time of drop off.
- All dogs must have a soft collar and ID tag. Leather, nylon, or cloth is fine, but no metal collars or choke chains. Initials _____
- Tuition can be paid in cash, check, or credit card and payment is due at the time of service.
- You must let us know at least 24-hours in advance of a cancellation to avoid being charged for scheduled services. You may tell us in person, or notify us by phone/email.
- Drop-offs and pick-ups are done between the hours of 7 am – 10 am and 4 pm – 6:00 pm, Monday-Friday (excluding holidays). Please be prompt about dropping off and picking up your dog. Our late fee is \$1/minute after pick up time and may be taken out of purchase daycare packages. If there is not an available staff member able to stay late, your dog(s) will be boarded for the evening and available for pick up the following day during our normal pick-up time(s). Owner Agreement

1. I understand that I am solely responsible, financially and/or otherwise, for any harm or damage caused by my dog(s) while at/near Happy Puppy.

2. For each and every visit, I understand and agree that while my admitting my dog(s), Happy Puppy has relied on my representation that my dog(s) is/are in good health and free from any communicable condition or diseases, and has not had such a condition in the prior 30 days. I further certify for each and every visit, that my dog(s) has/have received the following and are/will remain current medically as follows:

Distemper/parvo, bordetella (in system for at least 3 days), and rabies (for all dogs over 5 months of age) vaccines are all current and all boosters have been completed for puppies. Fecal (most recent) is negative and no older than 1 year, flea/tick prevention is current, and heartworm medication is current.

3. I understand and agree that Happy Puppy Doggie Daycare, its owner(s), employees, volunteers and affiliates will not be liable for any problems that develop from attending daycare at Happy Puppy, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever.

4. I understand and agree that with any issues that develop due to my dog(s) participation at Happy Puppy, on/near the premises or in arrival/departure from Happy Puppy, as owner/handler of the dog, I assume full responsibility for my dog's actions and the consequences thereof. I assume full financial responsibility for any and all expenses involved.

5. I understand and agree that all daycare packages, daily daycare tuitions, boarding tuitions, fees, and deposits are non-refundable.

6. I understand and agree that Happy Puppy reserves the right to take my dog(s) to any veterinarian of their choosing in the event my dog(s) needing urgent medical care. I also give Happy Puppy the right to make medical decisions for my dog(s) if I am unavailable or cannot be contacted for any reason.

7. I have read, understand and agree to the Policies and Information form of Happy Puppy Doggie Daycare, and further certify that the information I have provided in the registration and health certification is correct.
